Hong Kong Life responds to "Novel Coronavirus Infection[#]" Provides HKD 1,000 Per Day Free Additional Hospital Income Benefit

In view of recent situation of the outbreak of the novel coronavirus, Hong Kong Life specially provides Free Additional Hospital Income Benefit with convenient and simplified claim services to equip customers with better protection. From now till 30 June 2020, for all Hong Kong Life customers, if the Life Insured is diagnosed as suffering from Novel Coronavirus Infection and hospitalized in Hong Kong public hospitals, Free Additional Hospital Income Benefit of HKD1, 000 per Life Insured per day of confinement will be paid. Hong Kong Life also offers additional death benefit, multiple condition exemptions, one-day speedy claims service and claims collection service.

Measures and services for Novel Coronavirus Infection of Hong Kong Life:

1. Free Additional Hospital Income Benefit

For all Hong Kong Life customers, if the Life Insured is diagnosed as suffering from Novel Coronavirus Infection and hospitalized in Hong Kong public hospitals the Free Additional Hospital Income Benefit of HKD1, 000 per Life Insured per day of confinement will be paid, maximum 30 days, with the maximum amount of HKD30, 000, from now till 30 June 2020.

2. Wavier of Waiting Period, Physician's Statement in Claim Form and Deadline for Claim Submission

For Life Insured who are diagnosed as suffering from Novel Coronavirus Infection, the relevant claims will be entitled to wavier of waiting period, physician's statement in claim form and deadline for claim submission. Claims documents such as discharge summary must be provided by the Life Insured as supporting of confirmed diagnosis.

3. Additional Death Benefit

In the event of the death of the Life Insured who is diagnosed as suffering from Novel Coronavirus Infection, an **Additional Death Benefit of HKD100,000** will be paid in addition to original benefits.







4. One-day Speedy Claims Service

If the Life Insured is diagnosed as suffering from Novel Coronavirus Infection and submitted all required supporting documents, claims regarding Novel Coronavirus Infection will be prioritized and completed within one working day*.

5. Claims Collection Service

Hong Kong Life offer Claims Collection Service. Our customer services team will collect the claims documents from customers at your door and you can submit the claims at home with ease and convenience.
